Net Generation of Subsidiary Power Plants in the First Three Months of 2020 Decreased by 7.8%

China Resources Power Holdings Company Limited (“CR Power”, stock code: 0836) today announced that total net generation of subsidiary power plants in March 2020 decreased by 6.0% to 10,755,983MWh from 11,437,845MWh for the same period of 2019. Total net generation of subsidiary power plants for the first three months of 2020 decreased by 7.8% to 33,382,995MWh compared to 36,202,632MWh for the same period of 2019. (Note: The above generation volume does not include the volume sold to independent third parties.)

On a same plant basis, total net generation of subsidiary coal-fired power plants for the first three months of 2020 decreased by 19.3% compared to the same period of 2019. Power plants located in Hubei, Guangdong, Jiangsu, Henan, Hebei and Other provinces recorded 42.3%, 23.4%, 23.1%, 14.4%, 6.3% and 3.1% decreases year on year, respectively.
