Net Generation of Subsidiary Power Plants Increased by 3.8%,
among which Subsidiary Wind Farms Increased by 13.3%,
Photovoltaic Plants Increased by 81.0%**

Total net generation of subsidiary power plants in August 2023 decreased by 12.3% year on year to 17,307,851 MWh, among which, subsidiary wind farms decreased by 21.4% year on year to 2,163,688 MWh, subsidiary photovoltaic plants increased by 194.7% year on year to 341,427 MWh.

Total net generation of subsidiary power plants for the first eight months of 2023 increased by 3.8% year on year to 128,189,959 MWh, among which, subsidiary wind farms increased by 13.3% year on year to 26,271,261 MWh, subsidiary photovoltaic plants increased by 81.0% year on year to 1,665,835 MWh.
