Net Generation of Subsidiary Power Plants Increased by 5.7%,
among which Subsidiary Wind Farms Increased by 5.8%,
Photovoltaic Plants Increased by 209.9%**

Total net generation of subsidiary power plants in May 2024 increased by 6.7% year on year to 16,024,702 MWh, among which, subsidiary wind farms decreased by 2.7% year on year to 3,605,750 MWh, subsidiary photovoltaic plants increased by 276.8% year on year to 654,865 MWh.

Total net generation of subsidiary power plants for the first five months of 2024 increased by 5.7% year on year to 81,386,780 MWh, among which, subsidiary wind farms increased by 5.8% year on year to 19,296,895 MWh, subsidiary photovoltaic plants increased by 209.9% year on year to 2,485,475 MWh.
