Net Generation of Subsidiary Power Plants Increased by 22.6%,
among which Subsidiary Wind Farms Increased by 49.9%**

Total net generation of subsidiary power plants in June 2021 increased by 15.9% year on year to 15,242,775MWh, among which, subsidiary wind farms increased by 45.8% year on year to 2,279,339MWh.

Total net generation of subsidiary power plants for the first six months of 2021 increased by 22.6% year on year to 86,105,125MWh, among which, subsidiary wind farms increased by 49.9% year on year to 16,106,638MWh.
